MINUTES OF THE ANNUAL MEETING
January 25, 2023**

Call to Order: President Hubbard called the annual meeting of the Villa Park Public Library Board of Trustees to order at 7:01 p.m.

Report of the Board President: Hubbard reported the library has had a good year. Hubbard shared she has received positive feedback from patrons she has spoken to.

McCleary moved the Secretary cast a unanimous vote for Koeller for Vice-President. Hovanec seconded the motion, and the motion carried on voice vote. Koeller was elected Vice-President.

For the office of Secretary, McCleary nominated Luebker. Canale seconded the motion. McCleary moved the nominations be closed. De La Rosa seconded the motion, and the motion carried. McCleary moved the Secretary cast a unanimous vote for Luebker for Secretary. Hovanec seconded the motion, and the motion carried on voice vote. Luebker was elected Secretary.

For the office of Treasurer, Canale nominated McCleary. Luebker seconded the motion. Luebker moved the nominations be closed. Hovanec seconded the motion, and the motion carried. De La Rosa moved the Secretary cast a unanimous vote for McCleary for Treasurer. Luebker seconded the motion, and the motion carried on voice vote. McCleary was elected Treasurer.

Selection of Friends of the Villa Park Library Liaison: Hubbard appointed Luebker as the Friends of the Villa Park Library liaison and Koeller as the alternate.

Selection of RAILS Reporter: Hubbard appointed Krettler as the RAILS Reporter.

Selection of Legislative Reporter: Hubbard appointed De La Rosa as the Legislative Reporter.

Representation at Policy Committee Meetings during the Coming Year: Hubbard appointed De La Rosa, Hovanec, and Koeller as members of the Policy Committee. Hubbard is an alternate for the committee.

Representation at Finance Committee Meetings during the Coming Year: Hubbard appointed McCleary (chair), Canale, and Luebker as members of the Finance Committee. Hubbard is an alternate for the committee.

Representation at Building Committee Meetings during the Coming Year: Hubbard appointed De La Rosa, Hubbard, and McCleary (alternate) as members of the Building Committee.

Representation at Ad Hoc Strategic Planning Committee: Hubbard appointed Birmingham, Canale, De La Rosa, Hill, Hovanec, Hubbard, Koeller, Krettler as members of the Ad Hoc Strategic Planning Committee.

Annual Appointment of OMA Designee/FOIA Officer: Hubbard appointed Hill and Krettler as the OMA Designees and FOIA Officers.

Adjournment: McCleary moved the meeting be adjourned. Koeller seconded the motion, and the meeting was adjourned at 7:12 p.m.
